## **PROCESS FOR FILLING UPCOMING VACANCY FOR U.S. DISTRICT JUDGESHIP IN NORTHERN DISTRICT**

U.S. Sens. Sherrod Brown and George V. Voinovich announced the start of the process for recommending a candidate to fill the vacancy on the U.S. District Court for the Northern District of Ohio. The vacancy will be created when Chief Judge James G. Carr assumes senior status on June 1, 2010.
