What is Alternate Dispute Resolution?

There are various methods of resolving legal disputes without resorting to the courts. The most common methods are mediation and arbitration.



Mediation

Mediation is an assisted negotiation process. A neutral mediator selected by the parties to the dispute helps the parties discuss and generate options for reaching a settlement. The mediator does not decide which party is right, but focuses on helping the parties reach a resolution that is satisfactory to all.

Arbitration

Similar to litigation, the parties and their attorneys present evidence and legal arguments to a legal arbitrator. The arbitrator then makes a decision about who is right and who is wrong. The parties may select binding or non-binding arbitration.
